The school has deposited the inspection fee of Rs. 10,000/- vide GR No. 4300008 dated 20.06.2022. Accordingly the building safety certificate of the school has been issued for the year 2022-23 subject to following terms & conditions: -

1. In case, after this inspection any increase or change is affected in the building that change should be done under the supervision of an accredited engineer and the building safety certificate should be obtained from approved structural engineer. Thereafter, the building safety certificate should be again obtained from this Department.
2. In case of any damage to the school building due to any natural calamity or any other reason, even then the school head will have to inform this office immediately for necessary action.
3. The Fire Safety Certificate of this building has been issued by Punjab Fire Service Mohali, vide NOC No. Dated 21.12.2021. This should be insured that as per the instructions of the Fire Safety Department, the fire extinguishing equipment is satisfactory and it should be insured that school employees are trained in the fire extinguishing process.

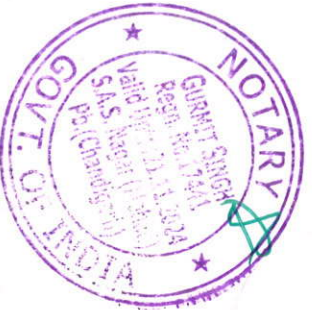




